**Promotional Period for Introductory APR:**

The Introductory APR for balance transfers will apply to transactions posted to your account from 01/01/2022 until 06/30/2022. Any existing balances on Ukrainian Federal Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

**Loss of Introductory APR:**

We may end your Introductory APR for balance transfers and apply the Penalty APR if you are 60 days late in making a payment.

**Application of Penalty APR:**

Your APR may be increased to the disclosed Penalty APR if you are 60 days late in making a payment.

**For California Borrowers, the UFCU Everyday Rewards Visa, Premier Rate Visa, Elite Signature Visa and Secured Visa are secured credit cards. Credit extended under this credit card account is secured by various personal**

property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings. Notwithstanding the foregoing, you acknowledge and agree that during any periods when you are a covered borrower under the Military Lending Act your credit card will be secured by any specific Pledge of Shares you grant us but will not be secured by all shares you have in any individual or joint account with the Credit Union. For clarity, you will not be deemed a covered borrower if: (i) you establish your credit card account when you are not a covered borrower; or (ii) you cease to be a covered borrower.

**Other Fees & Disclosures:**

Late Payment Fee:

\$27.00 or the amount of the required minimum payment, whichever is less, if You are 5 or more days late in making a payment. In the event You fail to make a payment on time, You will be charged \$35.00 or the amount of the required minimum payment, whichever is less until you make one payment by the payment due date.

Cash Advance Fee (Finance Charge):

\$10.00 or 1.00% of the amount of each cash advance, whichever is greater.

Returned Payment Fee:

\$27.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$20.00.

Rush Fee:

\$39.00.

Statement Copy Fee:

\$1.00.
